As a school we have found it more effective to complete whole class guided reading lessons in Key stage 2 (from January 2018), to ensure all pupils are fully engaged and active throughout the lesson. It is more beneficial to continue with the carousel group system in Key Stage 1 as there is more focus on word recognition and fluency which can be better supported in ability related groups. Whole class guided reading sessions in Key Stage 2 has resulted in every child having a supported comprehension lesson daily which will impact positively on Spring term progress data.</p>
