Vision statement:

Our aim is to use the natural outdoor woodland area to offer the children and practitioners a shared understanding of the ethos of a Forest School experience. This approach to outdoor learning encourages children to become independent, use their imagination, take appropriate risks within boundaries, be self-motivated, courageous, considerate, cooperative and to initiate learning for themselves.

Forest School is a holistic approach to learning, incorporating children's individuality and develops their skills for lifelong learning. It can cover all six areas of the primary curriculum (expressive arts; health and wellbeing; humanities; languages, literacy and communication; maths and numeracy; and science and technology) and The Early Years Foundation Stage areas of learning. It also includes emotional and spiritual aspects of learning where self-esteem and self-confidence can grow and positive relationships with peers can be formed, for all children.

Forest School explores the outdoors and the natural environment with practical, useful activities all year round, where a respect for nature is fostered. It develops peer learning with the adults providing support and enabling activities to take place where children will have the opportunity to use their personal learning style to complete tasks.

Communication:

Communication will be sent through a termly report to governors, it will also be shared via the school website www.st-josephs.hereford.sch.uk

As a school we also communicate with parents and guardians through our social media pages on face book and Instagram, as well as the weekly newsletter which is sent out to everyone.

As a school we also use a virtual learning platform - Evidence Me, to keep parents and guardians informed of leaning what has been happening.

History of Forest School

Our forest school area was part of the school playing field which has now been sectioned off by a willow structure fence to have a safe and secure boundary. This area was completed in 2019 to provide children with a purposeful, forest school setting and we continue to develop this area to meet the needs of our enriching curriculum.

Rules of forest school:

1. Look after your Forest School
2. Do not pick anything growing
3. Do not put your fingers or anything else in your mouth
4. Stay within the boundary rope, we don't go over it we don't go under it



The countryside code:

There are five sections of The Countryside Code dedicated to helping us learn how to respect, protect and enjoy the countryside:

1. Be safe, plan ahead and follow any signs
2. Leave gates and property as you find them
3. Protect plants and animals and take your litter home
4. Keep dogs under close control
5. Consider other people

Procedures of forest school routine:

1. Change children into forest school clothes
2. Change shoes into wellies or suitable footwear
3. Toilet children
4. Sing the forest school song as we travel to forest school
5. Sit around base camp and do mindful breathing
6. Explain the challenge for the session
7. Children to go and complete challenge
8. Reflect back at base camp
9. Make way back to classroom
10. Taking of wellies
11. Changing back into school uniform



You must have a specific risk assessment for Fire and Fire management in your Forest school site

Dynamic risk assessment:

Accident or minor injury:

- A first aid kit will always be on site at forest school
- Minor incidents will be dealt by the forest school leader or qualified member of staff
- If additional treatment is required the child will be taken back to the main building by the member of staff who is the runner for the day
- Major accidents we will ring 999 using information found on laminate card these include what three words, address.

Evacuation of the site:

- Forest school leader will shout 123 base camps where all students will return safely
- We will walk to the designated meeting point on the playground and await further instruction.

Missing child:

- If a child goes missing when at forest school another adult will lead the class back into the main school while the forest school leader will continue looking.
- The member of staff who has returned back to school will inform DSL to help and assist.

Lockdown

- We will make our way to the school hall which is located by forest school and wait their until further instruction.

Weather:

- If the weather changes whilst out at forest school the forest school leader will shout 123 base camp and we will walk back into the main building.

Designated person responsible:

Providing children with an opportunity to learn through forest school, by letting the explore and connect with nature. We have a tyre swing for children to explore as well as tress which will be maintained and managed with a member of staff to help support the children. Letting the children play in the mud kitchen and Wendy house creating imaginative play and letting them develop their senses and creativity through play.

The assistant will manage different areas of forest school such as the tyre swing, climbing trees and the boundaries to forest school making sure no children leave without asking permission or without an adult for younger years.

Toilet considerations:

All children will visit the toilet before leaving the classroom. Any children needing the toilet during the session will use the school toilets. KS2 children are able to go unattended; KS1 and nursery must be accompanied by an adult.

Ecological impact and 3 year plan:

Footfall and impact to flora	Use pathways already established when walking to forest school, identify vulnerable areas and avoid them if possible.
Football on the field	Moving the goal post around the field so certain areas have time for re growth. Letting children play on the nursery playground when possible so the field isn't impacted.
Noise impact on wildlife	Teaching children to be respectful and if we see any wildlife reminding children to be calm and quiet.
Habitats	Teaching children to not touch habitats what we find, also providing bird boxes, hedgehog homes.
Over use of areas	Move to different areas, so the ground doesn't become impacted and gives time for regrowth.

Lyme disease

Lyme disease is a bacterial infection that can be spread to humans by infected ticks. It's usually easier to treat if it's diagnosed early.

Symptoms of Lyme disease

A circular or oval shape rash around a tick bite can be an early symptom of Lyme disease in some people.

The rash can appear up to 3 months after being bitten by an infected tick, but usually appears within 1 to 4 weeks. It can last for several weeks.

The rash can have a darker or lighter area in the centre and might gradually spread. It's not usually hot or itchy.

The rash may be flat, or slightly raised, and look pink, red, or purple when it appears on white skin. It can be harder to see the rash on brown and black skin and it may look like a bruise.

Some people also get flu-like symptoms a few days or weeks after they were bitten by an infected tick, such as:

- a high temperature, or feeling hot and shivery
- headache
- muscle and joint pain
- tiredness and loss of energy
